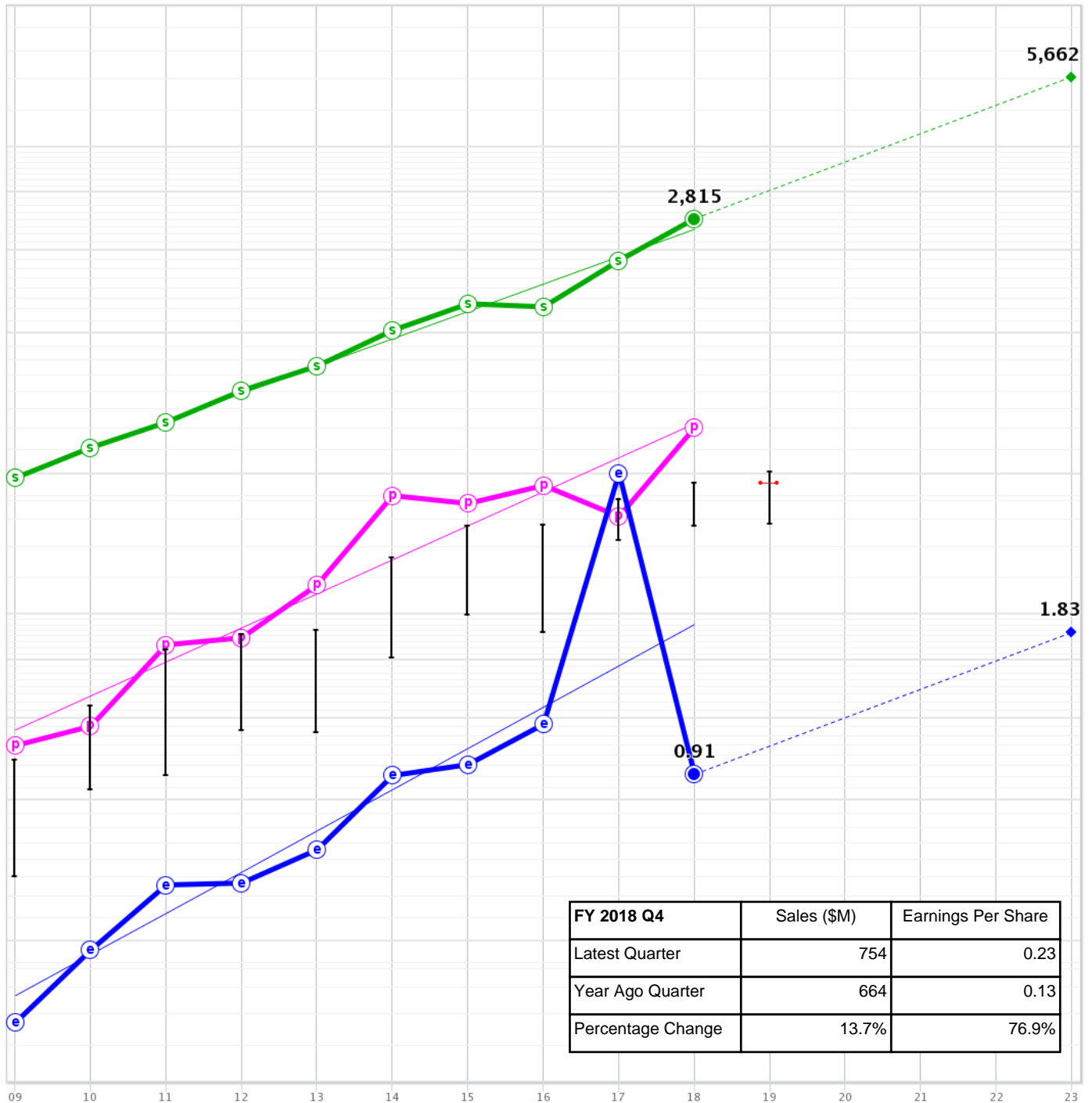

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 27.8 X Estimate High Earnings/Share 1.83 = Forecasted High Price \$ 50.9

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 19.1 X Estimate Low Earnings/Share 0.91 = Forecasted Low Price \$ 17.4

(b) Avg. Low Price of Last 5 Years 22.8

(c) Recent Market Low Price 28.8

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.61}{2.39\%} = 25.4$

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{50.9 - 38.18}{38.18 - 22.8} = \frac{12.70}{15.35} = 0.8$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{50.9 - 38.18}{38.18} = 1.3327$ X 100 = 133.27 - 100 = 33.3 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.55}{38.18} = 0.0159 = 1.6\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{37.6\%}{27.80} = 1.4\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{37.6\%}{23.45} = 1.6\%$

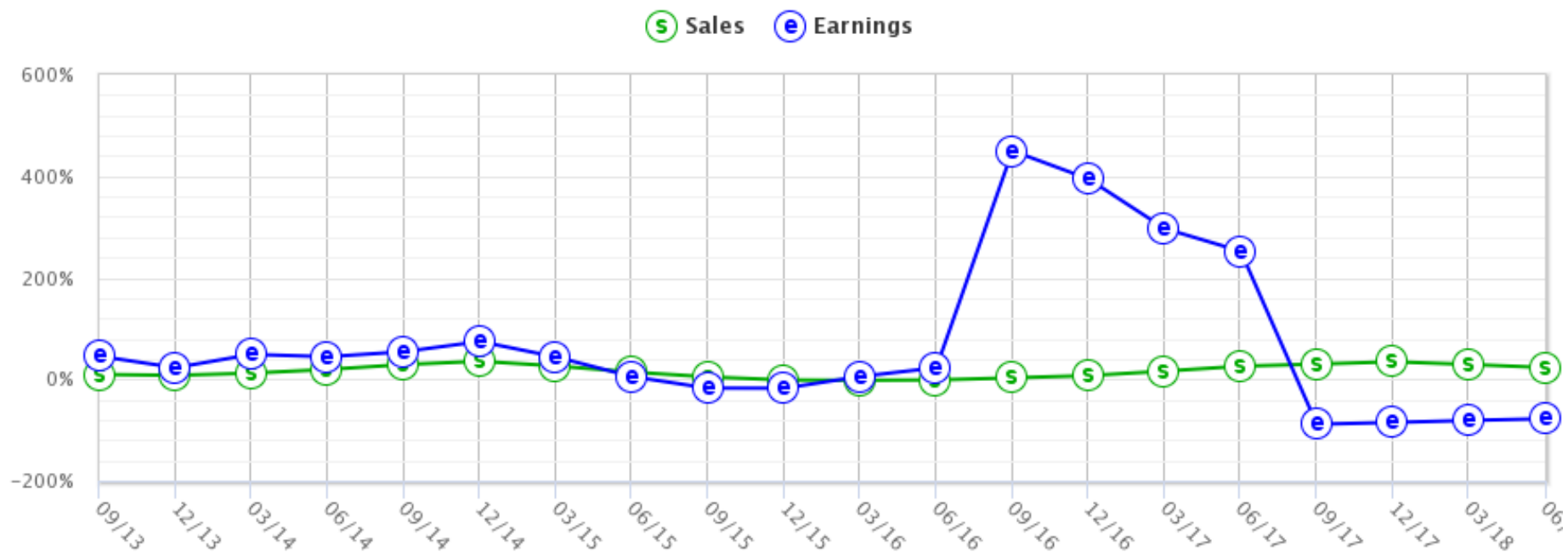
